Date, Time, and Location of the Public Scoping Meeting

The public meeting was held on May 30, 2019, from 5:00 p.m. to 7:00 p.m. at the Teton County Library Auditorium, 125 Virginian Lane, Jackson, Wyoming.

Purpose of Public Scoping Meeting

The purpose of the open house is to present information on the project background and history, purpose and need, objectives, issues, and next steps. Another critical aspect of the meeting is to gather input from the public about their issues and concerns. These public comments will help inform the issues to be addressed in the Environmental Assessment being prepared for the project.

Three (3) traffic handouts were available as handouts and are included in Attachment A. Handouts showed:

- Location of trips in 2016 and 2040 traffic volumes
- Traffic volumes at key locations within the project area in 2016 and 2040 traffic volumes
- Traffic volumes on High School Road in 2016 and 2040 traffic volumes.

Comment sheets were provided to attendees to complete and submit at the public meeting, or commenters could submit by June 24, 2019.

Public Scoping Meeting Attendees

There were 80 people who signed in at the public meeting. Attendees included property owners, home owners, residents, and commuters. Sign-in sheets are included in Attachment B.

Comments Received

A total of 63 comments were submitted either at the public meeting or by the June 24, 2019 deadline. Comments voiced support and opposition for the project. Common concerns included impacts to abundant wildlife in the project area; Study Area is too narrow and needs to include adjacent roads and intersections; whether now is the proper time to build the Connector considering other projects planned for the area; and whether commercial and long-distance traffic will use the connector as a cut-through route.

Comments received are summarized below. The study team used the comments to expand the Frequently Asked Questions page on the Tribal Trail Connector website, <u>www.tribaltrailconnector.com</u>. Copies of all the comment forms and comment emails are also available on the website. Comments provided on meeting exhibits are included in Attachment C.


Subject of Comment	Comment
Quality of life	Protect the overall aesthetics of the area.
Natural Resources	 Wildlife in the area present year-round, especially during winter months: elk, deer, moose, waterfowl, trout, fox, and eagles. How will the hydrology of the area be impacted, especially accounting for the water table? Reduce speeds to reduce wildlife collisions. Consider Wildlife underpasses. Wildlife protection must be a priority. Wildlife migration corridor information feels incomplete and not completely accurate.
Public involvement	 Presentation presents the project as a done deal. Didn't address possibility of not constructing the project. The work is appreciated but needs a more balanced information on other options to alleviate the need in the area. Form questions were misleading. Information should be as accurate as possible, as it will influence public opinion.
Support project	 Support for the project remains since it was first introduced to the area. This project has always been a part of the long-term plan. Build it. In support of the project but be mindful of the impacts it could have on adjacent neighborhoods and the multimodal options that the pathways currently provide. A well-designed Tribal Trail Connection will be an asset. Traffic speeds at the Hwy 22/89 are unsafe to pedestrian and bikes. Indian Trails was platted with this road a part of the County and State Transportation Plan

Oppose project Study	 Should not build more roads as it leads to development and more people. This will turn into a high-speed cut-thru for travelers. Project impacts outweigh the benefits. This will turn into a short cut for long distance and commercial traffic: trucks, tourists, and non-local traffic. Feels like the planning process is ignoring comments which do not support the connector. Special interest groups are specifically seeking out supporters in favor of the Connector. This plan is merely shifting the congestion problem, not fixing it. Process lacks monitoring both before and after. Needs clearly defined Purpose and Need.
	 Study should address and incorporate improvements to adjacent roads and intersections. Connection should incorporate access improvements Indian Springs and the Teton Science School. Justification for the project needs to be more concrete. Consider alternate routes to alleviate the needs in the area. Impacts to new/existing schools during pick up and drop off. Has widening of Hwy 22 been studied? Scope is too limited, need to consider Spring Gulch and the high school. Missing high school traffic data in the analysis. Tribal Trails cannot be considered in isolation from Highway 26/89/191 and Spring Gulch Road Concern if proper modeling used.
Noighborhood	 Modern navigation systems will direct people through what is
Neighborhood impacts	 Modelin havigation systems will direct people through what is supposed to be a local connector road. Should restrict trucks form using the connector. The traffic suggested traffic pattern would degrade the rural character of the area. The Connector would create the need for noise barriers and privacy fences.
Design elements	 This project would not alleviate summer back up. Design should prohibit large trucks. Only allow START and school busses. Speed limit of Connector should be kept low. Include traffic calming measure (speed humps, stop signs, low speed limits) How will this ensure this remains a connector and not turn into a bypass. Speeds should be enforced by ticketing cameras. What about a round-a-bouts along the Connector or stop signs at each intersection.
Water resources	• Project location in the 100-year floodplain need to be included.
Project Cost	• This project's anticipated cost is too high compared to other project estimates.
Bike/pedestrian facilities	• Are there any ideas on the management of e-bike growth?
Safety	 Children safety and young families Proximity of road to homes in Indian Trails is too close. Children playing in the neighborhoods, more traffic puts them at a higher risk.



START	Expand START services, especially in winter.
Timing	 Why now? Study is too rushed to have completed in a summer. Wait to see how the expansion of HWY 22 impacts traffic and congestions before building the Connector. Expand Hwy 22 before you build new roads in neighborhoods. Wait and see if the new Y connector design will alleviate congestion.
Emergency Services	 Disagree this is needed for emergency vehicle egress. They often open the gates for access. If emergency access is the issue what about other options aside from building the Connector. Perhaps expand the bike trail? Fire response often stuck in traffic, this will help their response time.







2016 Traffic Volumes with Tribal Trail Extension




2040 Traffic Volumes with Tribal Trail Extension










Location of trips using the Tribal Trail Extension (2040)
